The Applicant is also requesting an SDM License to be held in conjunction with the Class C License; however, Council approval is not needed for the SDM License. The applicant plans to operate the business as a restaurant with a menu that includes a variety of burgers, sandwiches, soups and salads, deserts, etc.

Planning and Development Services has approved the application subject to a final inspection after the building has completed construction. There are no delinquent property taxes, all application fees are paid and there are no objections from City Staff.
