On February 19, 2008 (R-08-069), Council approved an allocation of \$50,000.00 in Ann Arbor Housing Trust Funds and \$20,000.00 in General Funds to fund Mortgage Foreclosure Intervention and Prevention Services to Legal Services of South Central Michigan and the Washtenaw County Treasurer per Resolution R-08-069. The Resolution should have specified General Fund Reserves but it said "General Fund" instead. This Amendment adds the word "Reserves" to specify the correct account.
