Resolution Recognizing Washtenaw Alano Club as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

The Washtenaw Alano Club is a local non-profit organization with a mission to provide a facility and an environment conducive to spiritual growth for recovery from addictive behavior. Washtenaw Alano Club achieves its mission by owning and operating a support center that is home to the largest and most diverse offering of 12-step recovery meetings in Washtenaw County. With more than 55 recovery meetings a week, 1,500 - 1,700 visitors each week and 10 distinct 12-step programs, the Washtenaw Alano Club strives to build an accessible and vibrant recovery support community.

Passage of the attached resolution will allow the Washtenaw Alano Club to host a Poker Palace night at Belmark Lanes in order to fundraise money to further its mission. This resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for the event.
