Whereas, The Michigan Supreme Court State Court Administrative Office (SCAO) has awarded \$75,000 to the 15th Judicial District Court for in-patient and out-patient drug abuse counseling and rehabilitation services to 15th Judicial District Court defendants who are participants in the Court's Sobriety Court program for Grant Year 2012;
