Resolution to Close Spring Street between Miller and Cherry on Sunday, May 5, 2019 for the Water Hill MusicFest Continued Special Event

Attached for your consideration is a resolution to approve the closing of Spring Street between Miller and Cherry for the Water Hill MusicFest Continued special event. The event will close the street from 11:00 AM until 6:00 PM. The actual event will run from Noon until 5:00 PM, with the additional time for set-up and clean-up.
