Whereas, The Ann Arbor City Planning Commission, on March 6, 2012, recommended approval of

the petition;

Whereas, The development would comply with the C3, Fringe Commercial, zoning established pursuant to the requirements of Chapter 55, and with all applicable local, state, or federal laws, ordinances, standards and regulations;

Whereas, The development would limit the disturbance of natural features to the minimum necessary to allow a reasonable use of the land, applying criteria for reviewing a natural features statement of impact set forth in Chapter 57; and

Whereas, The development would not cause a public or private nuisance and would not have a detrimental effect on the public health, safety and welfare;

RESOLVED, That City Council approve the Tim Hortons Site Plan dated 2/16/12 upon the condition that a land division is approved prior to issuance of any permits for construction of the new building.
