## **PROCLAMATION**Honoring Carol Kuhnke

December 17, 2012

WHEREAS, The City of Ann Arbor depends on numerous qualified citizens to volunteer their time and talents to assist the City in numerous endeavors requiring service on various Boards, Committees, Commissions and other groups; and

WHEREAS, Ann Arbor attorney Carol Kuhnke was first appointed by Council upon the recommendation of Mayor Ingrid
Sheldon to serve as a member of the Zoning Board of Appeals effective January 1, 2000 and was twice
reappointed by Council upon recommendation of Mayor John Hieftje to another three year term after
which Carol Kuhnke was unanimously approved and appointed to serve as Chair of the Zoning Board of
