An Ordinance to Amend Chapter 55 (Zoning), Rezoning of 0.46 Acre from TWP (Township District) to R1A (Single-Family Dwelling District), McMullen Property, 3100 Geddes Avenue (CPC Recommendation: Approval - 8 Yeas and 0 Nays) (Ordinance No. ORD-13-11) This ordinance will zone this property to R1A (Single-Family Dwelling District), now that the property has been officially annexed into the City. The proposed zoning is consistent with the adjacent zoning, the surrounding land uses, and the City's Master Plan. The City Planning Commission, at its meeting of December 4, 2012, recommended approval of the request. The Michigan Secretary of State's Office recently confirmed that all statutory requirements have been complied with in order to complete the annexation.

The City of Ann Arbor ordains:
