Whereas, 3965 South State Associates, L.L.C., a Michigan limited liability company, is the owner of property commonly known as 3965 South State Street, Ann Arbor, Michigan 48108, described in Liber 4715, Pages 626-628 of Deeds, Washtenaw County Records;

Whereas, 3965 South State Associates, L.L.C. has executed and delivered a grant of easement for public right-of-way, more particularly described as:

Commencing at the Southwest corner of Section 9, T.3S., R.6E., City of Ann Arbor,

Washtenaw County, Michigan; thence N87°53'20"E 183.01 feet along the South line of

said Section 9 and the centerline of W. Ellsworth Road (43 foot half width) for a Place of

Beginning; thence N01°06'00"W 50.01 feet; thence N87°53'20"E 344.99 feet; thence

S01°06'00"E 50.01 feet; thence S87°53'20"W 344.99 feet along the South line of said

Section 9 and the centerline of said W. Ellsworth Road to the Place of Beginning.

RESOLVED, That the City of Ann Arbor hereby accepts this grant of easement.
