Resolution to Authorize a Sole Source Purchase Order to Jack Doheny Companies, Inc. for the Purchase of Parts and Service for Field Operation Utilities Unit Equipment (\$50,000.00/annually) Please find attached resolution for your consideration authorizing the issuance of a sole source purchase order to Jack Doheny Companies, Inc. of Northville, MI for purchase of parts and service for the Field Operations Utilities Units Vactor, Rodding truck and Video truck. Field Operations is requesting \$50,000.00/annually through June 30, 2017.

Jack Doheny Companies, Inc. provides maintenance and repair parts and service, as needed, due to wear from use. Those items may include jet hose, tiger tails, nozzles, vactor tubes, rod, saws, cutting knives for jetting & rodding operations. As well as, equipment and software needed to maintain the TV equipment used in the inspection of storm and sanitary main lines.

Jack Doheny Companies, Inc. is the sole distributor for Vactor Manufacturing, Inc. sales, OEM parts and serviced for the state of Michigan, in it's entirety, for the VACTOR and RAMRODDING products lines as well as for GUZZLER industrial cleaning equipment. The personnel at Jack Doheny Companies, Inc. have been factory-trained and are certified to provide quality service work on the above listed equipment.

Funds are available in the FY14 Field Operations Water, Storm and Sanitary Operating budgets. Funding will be included in future budgets, subject to approval by City Council of those budgets for FY15 and FY16.
