Resolution Recognizing the Pearls and Ivy Foundation Inc. as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License
To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Pearls and Ivy Foundation Inc. is a 501(c)3 non-profit organization that is organized for the general purpose of receiving and administering funds for the following:

- 1. The preservation and perpetuation of objects of historical interest or natural interest,
- 2. Higher educational needs,
- 3. Charitable giving to individuals or other nonprofit organizations, and
- 4. Support of public welfare programs.

Passage of the attached resolution will allow the Pearls and Ivy Foundation Inc. to hold a poker event at the Heidelberg, located at 215 N. Main Street, in Ann Arbor. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
