Resolution Accepting an Easement for Sanitary Sewer from Subaru Research and Development, Inc. (3995 Research Park Drive) (8 Votes Required)

Whereas, Subaru Research and Development, Inc., a California corporation, is the owner of property commonly known as 3995 Research Park Drive, Ann Arbor, Michigan 48108 described in Liber 4067 Page 542 of Deeds, Washtenaw County Records;

Whereas, Subaru Research and Development, Inc. has executed and delivered a grant of easement for sanitary sewer, being more particularly described as:

## VARIABLE WIDTH SANITARY EASEMENT:

Part of Lot 20, "RESEARCH PARK SUBDIVISION", as recorded in Liber 15, Page 56 & 57, Washtenaw County Records, described as; Commencing at the SW Corner of Section 9, Pittsfield Township, Washtenaw County, Michigan; thence N 87° 53′ 20″ E 528.00 ft along the South line of Section 9, also being the Centerline of Ellsworth Road (Variable Width) and N 1° 06′ 00″ W 43.01 ft to the POINT OF BEGINNING; proceeding thence along the West line of Lot 20 N 1° 06′ 00″ W 79.05 ft; thence N 87° 59′ 29″ E 187.95 ft; thence N 23° 25′ 00″ E 187.24 ft; thence N 19° 10′ 43″ E 261.64 ft; thence along the Southerly line of Research Park Drive Right of way (80 ft wide) on a curve to the left Radius of 899.43 ft, arc of 49.73 ft, the chord bears S 59° 30′ 25″ E 49.72 ft; thence S 23° 25′ 00″ W 514.94 ft along the Easterly line of said Lot 20;
