Resolution to Approve the Closing of Streets for the 2014 Glacier Area Homeowners Association Annual Memorial Day Parade, Monday, May 26, 2014

The following streets are requested for closure from 8:00 A.M. to Noon on Monday, May 26, 2014:

- Frederick Drive from Greenbrier Boulevard to Middleton
- Middleton to Bardstown Trail
- Bardstown Trail to Barrister Road ending before Larchmont
- Larchmont between MacGregor Lane and North Folkstone Court

The sponsor agrees to obtain all necessary permits, to provide evidence of proper liability insurance as required, to comply with all City regulations governing the use of the street and will reimburse the City for all event expenses.
