Whereas, Jeffrey J. Brink and Amy C. Brink have signed a grant of easement for public utilities, described as:

Commencing at the West 1/4 corner of Section 26, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan, thence S 89°43' E 738.33 feet along the East -West 1/4 line of said Section 26 to a point on the East right of way line of Huron Parkway; thence 130.34 feet along said right of way line, the arc of a circular curve to the left, radius 4845.00 feet, and a chord of N 13°35'33" W 130.34 feet to the Place Of Beginning; thence continuing along said right of way line 16.68 feet, the arc of a circular curve to the left, radius 4845.00 feet, chord N 14°27'42" W 16.68 feet; thence N 75°02'53" E 191.16 feet; thence N 15°02'44" W 17.33 feet; thence N 31°30'56' W 99.93 feet; thence N 74°08'00" E 41.54 feet; thence S 31°30'56" E 75.52 feet; thence N 58°29'04" E 7.15 feet; thence S 26°45'33" E 33.68 feet; thence S 74°57'16" W 8.31 feet; thence S 15°02'44" E 22.44 feet; thence N 75°02'53" E 10.00 feet; thence S 15°02'44" E 15.22 feet; thence N 60°41'50" W 3.48 feet: thence S 80°18'54" W 94.49 feet; thence
