Whereas, The City Council had directed the City Assessor to prepare a Special Assessment Roll for the purpose of defraying that part of the cost of the following described public improvement to be defrayed by Special Assessment: Construction of a new sidewalk system along the east side of Nixon Road - Resolution No. 3; Sidewalk Special Assessment District No. 46, File No. 2012-0362;

Whereas, The City Assessor has prepared said Special Assessment Roll and has the same on file in the Assessor's office with his certificate attached thereto; and

Whereas, The Michigan Tax Tribunal requires appearance and protest at the public hearing in order to appeal the amount of the special assessment, if an appeal should be desired;

Huron St. to receive public comment on the proposed Nixon Road Sidewalk Construction Project; Sidewalk Special Assessment District as described in the attachment to this Resolution; and
