Resolution Recognizing Fostering Futures as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Fostering Futures is a 501(c)3 non-profit child placing agency contracted with the State of Michigan to provide services to families and children in the foster care system.

Passage of the attached resolution will allow the Fostering Futures to hold a raffle at the Eagle Crest Golf Course in Ypsilanti, Michigan. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.

Whereas, P.A. 382 of 1972, as amended, requires that local civic nonprofit organizations be recognized by resolution adopted by the local governmental subdivision in which the organization conducts its principal activities and that a copy of said resolution be filed with any application for a license to conduct a bingo, raffle or charity game(s);

Whereas, Fostering Futures has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and

Whereas, Fostering Futures is a local civic nonprofit organization as defined by P.A. 382 of 1972, as amended, which should be recognized for providing services to families and children in the foster care system;

RESOLVED, That City Council hereby approve recognition of the Fostering Futures as a local civic
