Resolution Recognizing Stone School Cooperative Nursery as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Stone School Cooperative Nursery is a 501(c)3 civic nonprofit preschool for children in Ann Arbor and the surrounding area. The mission of Stone School Cooperative Nursery is to foster an environment allowing children to grow emotionally, mentally, physically and socially;

Passage of the attached resolution will allow the Stone School Cooperative Nursery to hold a raffle at the Bethlehem United Church of Christ, located at 211 Stone School Road, Suite 200, in Ann Arbor, Michigan. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
