Whereas, JAG Briarwood, L.L.C. has signed a grant of easement for water mains and appurtenances, described as:

Commencing at the SW Corner of Section 9, T3S, R6E, City of Ann Arbor, Washtenaw County, Michigan, thence N 01°06'00" W 247.53 feet along the west line of said Section 9 and the centerline of S. State St., thence N 87°53'20" E 50.01 feet to the POINT OF BEGINNING.

Thence N 01°06'00" W 40.01 feet along the easterly Right-of-Way line of S. State St.;

Thence N 87°53'20" E 187.26 feet;

Thence N 02°06'40" W 42.49 feet;

Thence N 87°53'20" E 40.00 feet along the northerly property line;
