Attached for your consideration is a resolution to approve the closing of E. Liberty Street between S. Fifth Avenue and S. Division Street for the deLights are Goin' on Downtown special event on Friday, November 16, 2007 from 5:00 PM to 7:30 PM. The Main Street Area Association is sponsoring this event to be held in conjunction with the City's tree lighting ceremony.

The sponsor agrees to obtain all necessary permits, to provide evidence of proper liability insurance as required and to comply with all City regulations governing the use of the street. The estimated cost for providing City services during the event is \$300.00. The sponsor will notify all affected religious institutions, businesses and residents in writing not less than 14 days before the event.

Traffic plans have been coordinated with Police, Fire and Transportation.
