Resolution to Approve Bogdasarian Annexation, 1.79 Acres, 2625 Newport Road (CPC Recommendation: Approval - 9 Yeas and 0 Nays).

Whereas, The territory hereinafter described is located in the Township of Ann Arbor and is adjacent to the corporate limits of the City of Ann Arbor;

Whereas, Ronald S. and Mary L. Bogdasarian are the owners of said property; and

Whereas, It is the desire of Ronald S. and Mary L. Bogdasarian to annex said territory to the City of Ann Arbor, pursuant to the provisions of Act 359 of the Public Acts of the State of Michigan for the year 1947, as amended;

RESOLVED, That the following described lands and premises situated and being in the Township of Ann Arbor, Washtenaw County, Michigan, be detached from said Township of Ann Arbor and annexed to the City of Ann Arbor, to-wit:

Commencing at the East ¼ corner of Section 18, T2S, R6E, Ann Arbor Township, Washtenaw County, Michigan; thence N 89°56' W 1327.84 feet along the E-W ¼ line of said section; thence along the centerline of Newport Road along the following courses: N 19°42'

W 340.67 feet (as monumented), N 25°20' W 485.20 feet, N 26° 33'30" W 470.41 feet for a Place of Beginning; thence S 63°26'30" W 463.30 feet; thence N 22°48'30" W 170.96 feet; thence N 63° 26'30" E 452.20 feet; thence S 26°33'30" E 170.59 feet along said centerline to the Place of Beginning; being part of the NE ¼ of said Section 18.
