Resolution to Close N. Fourth Avenue and E. Ann Street for the 13th Annual African-American Downtown Festival, Friday, June 6, 2008 to Saturday, June 7, 2008

Attached for your consideration is a resolution to approve the closing of East Ann Street from North Main Street to the Hands On Museum driveway near North Fifth Avenue (local traffic access maintained) and North Fourth Avenue from Catherine Street to East Huron Street from 6:00 P.M. on Friday, June 6, 2008 to 9:30 P.M. on Saturday, June 7, 2008 to stage the 13th Annual African-American Downtown Festival. This event, sponsored by the Community Leaning Post, will again celebrate the contributions of local African-Americans in the development of the City and to commemorate the former location of the African-American business district in the community.

The sponsor has requested the City waive all fees associated with this event:
