Resolution Authorizing Sanitary Sewer and Water Improvement Charges for 795 Arlington Boulevard (\$23,680.46)

Your approval is requested to levy the sanitary sewer and water improvement charges of \$23,680.46 on the property known as 795 Arlington Boulevard. The parcel is a result of a property split in 2005 from the parent parcel of 785 Arlington Boulevard. The applicable connection charges have been paid and the property is "active" for sanitary sewer and water service as of June 16, 2008.

According to current procedures, the property owner needs to now pay the property's share of the existing utilities through the City improvement charge levy as required under section 1:278, Chapter 12, of the Ann Arbor Code. The \$23,680.46 Utilities Improvement Charge is to be levied and then made payable in 15 annual installments at 5.00% interest per annum on the unpaid balance.

It is therefore recommended that Council levy this improvement charge according to the terms described above.

- 4. That the Public Services Area be directed to send a copy of this resolution by first class mail to the owners of the property and to promptly have this resolution recorded in the office of the Register of Deeds of Washtenaw County, Michigan; and
- 5. That this levied improvement charge be invoiced to the owner, James S & Susanne Denise DeMeester (husband & wife), of the property known as 795 Arlington Boulevard, City of Ann Arbor, Washtenaw County, Michigan 48105, and to be invoiced at 2447 Mulberry Ct, Ann Arbor, MI 48104, and to be credited in the amount of \$14,799.27 to Fund 0043-073-8000-7151 and \$8,881.19 to Fund 0042-073-8000-7151.
