Resolution to Approve a Temporary Liquor License to Ozone House Youth and Family Services -End of Summer/Fall Harvest Dinner on Friday, September 19, 2008 at the Ann Arbor Farmer's Market The Ozone House Youth and Family Services has applied for a non-competitive special event permit through the Planning and Development Services Unit. The event is for the Ozone House End of Summer/Fall Harvest Dinner on Friday, September 19, 2008 at the Farmer's Market. The event is taking place on City Parks property and the applicant is requesting a temporary liquor license in order to serve beer at the event. Admission tickets by invitation only will be sold, which include the price of alcohol and dinner.

Approval by City Council is required in order for the applicant to receive a temporary liquor license from the Michigan Liquor Control Commission. City staff have administratively approved all other requirements for the event and approval of this resolution is recommended.
