## PENSKE TRUCK LEASING ZONING (1621 PLYMOUTH ROAD)

AN ORDINANCE TO AMEND THE ZONING MAP BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR.

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the NE corner of Section 21, T2S, R6E, Ann Arbor Township, Washtenaw county, Michigan, thence S 2°14'30" W 909.60 feet along the east line of said Section 21, thence N 87°35'30" W 683.20 feet, thence S 3°34'00" W 22.57 feet to a point in a circular curve for a PLACE OF BEGINNING; thence N 3°34'00" E 22.57 feet; thence N 42°12'00" W 353.60 feet; thence S 40°32'00" W 109.60 feet; thence S 42°23'0" W 90.40 feet; thence S 42°12'00" E 111.59 feet to a point in a circular curve; thence southeasterly in the arc of a circular curve to the right a distance of 301.39 feet, chord subtending said arc having a bearing of S 79°58'00" E and being 297.63 feet in length, central angle of 88°11'00", radius 549.88 feet, to the PLACE OF BEGINNING, being part of the NE ¼ of Section 21, T2S, R6E, Ann Arbor Township, Washtenaw County, Michigan, and containing 1.20 acres of land, more or less,

in the City of Ann Arbor, Washtenaw County, Michigan as C1 (Local Business District).

Section 2. This ordinance shall take effect and be in force on and after ten days from legal publication.
