Whereas, Watershed L.L.C., a Michigan limited liability company, is the owner of property commonly known as 3572 Plymouth Road, Ann Arbor, Michigan 48105, described at Liber 4040, Page 400 of Deeds, Washtenaw County Records; and

Whereas, Watershed L.L.C. has signed a grant of easement for sanitary sewers and appurtenances, described as:

A 36 foot wide sanitary sewer easement over the above described Parcel No. 09-09-14-401-006, being lands in the Southeast 1/4 of Section 14, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan, said easement being more particularly described as:

Commencing at the South 1/4 corner of said Section 14; thence along the South line of said Section 14, S89°19'45"E, 541.10 feet to the West line of Parcel No. 09-09-14-401-008; thence along said West line, N00°05'50"E, 511.73 feet to the POINT OF

BEGINNING; thence along said easement the following four (4) courses:

- 1) (L1) S52°03'03"W, 16.13 feet;
- 2) (L2) N37°56'57"W, 36.00 feet;
- 3) (L3) N52 $^{\circ}$ 03'03"E, 44.30 feet to the aforementioned West line of Parcel No. 09-09-14-401-008 and;
- 4) along said West line, (L4) S00°05'50"W, 45.71 feet to the POINT OF BEGINNING. Containing ±1,088 square feet of land.
