Whereas, Stellar Hospitality Ann Arbor, LLC is the owner of property commonly known as 3850 Research Park Drive, described at Liber 5101, Page 202 of Deeds, Washtenaw County Records; and

Whereas, Stellar Hospitality Ann Arbor, LLC has signed a grant of easement for water mains and appurtenances, described as:

An easement in the City of Ann Arbor, Washtenaw County, Michigan: Commencing at the northwest corner of Lot 22 of Research Park, as recorded in Liber 15 of Plats, Pages 56 and 57, Washtenaw County Records; thence along the southerly Research Park Drive right-of-way N88°54'00"E 230.29 feet to the POINT OF BEGINNING; thence continuing along said southerly right-of-way N88°54'00"E 49.71 feet; thence S09° 14'10"W 205.22 feet; thence S54°11'58"W 37.94 feet; thence N80°48'02"W 204.43 feet; thence S54°11'58"W 0.83 feet; thence S09°11'58"W 252.22 feet; thence S35°48'02"E 0.83 feet; thence S80°48'02"E 121.55 feet; thence S09°11'58"W 60.75 feet; thence N80°48'02"W 40.00 feet; thence N09°11'58"E 20.75 feet; thence N80°48'02"W 98.12 feet; thence N35°48'02"W 52.31 feet; thence northeasterly 263.81 feet along a 1680.86 foot radius curve to the right, chord bearing N10°56'39"E 267.69 feet; thence N54°
