Whereas, South State Street Ann Arbor Retail LLC has signed a grant of easement for water mains and appurtenances, described as:

Commencing at the West 1/4 corner of Section 9, Town 3 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan thence N 01°39'00" W 1376.30 feet along the West line of said Section 9 and the centerline of South State Street (variable width); thence N 87°22'30" E 100.00 feet to the easterly right-of-way line of South State Street; thence N 01°39'00" W 57.41 feet along said right-of-way to the POINT OF BEGINNING; thence continuing N 01°39'00" W 40.00 feet; thence N 88°21'00" E 60.62 feet; thence N 02°32'13" W 32.15 feet; thence N 42°38'43" E 39.84 feet; thence N 65°08'43" E 76.47 feet; thence N 87°42'20" E 382.40 feet; thence S 01°39'00" E 40.00 feet; thence S 87°42'20" W 373.97 feet; thence S 64°50'27" W 60.22 feet; thence S 44°11'54" W 15.42 feet; thence S 02°32'13" E 82.41 feet; thence S 87°27'47" W 40.00 feet; thence N 02°32'13" W 26.90 feet; thence S 88°21'00" W 61.24 feet to the POINT OF
