To Approve the Ann Arbor Housing Commission FY19 Annual Action Plan (July 1, 2018 to June 30, 2019)

The Quality Housing and Work Responsibility Act of October, 1998 introduced Five-Year and Annual PHA Plans to provide a ready source for interested parties to locate basic PHA policies, rules and requirements concerning the PHA's operations, programs and services and to inform HUD, families served by the PHA, and members of the public of the PHA's mission and strategies for serving the needs of the low-income and very low-income families.

The Commission submitted a Five-Year Plan for 2016-2020 in April 2015 and is required to submit to HUD an FY19 Annual Plan no later than April 17, 2018. AAHC staff met with the Resident Advisory Board (RAB) to review, discuss and answer questions regarding the Agency Plan, which are incorporated into the Plan.

The AAHC's Annual Plan was on public display for a minimum of 45 days at the Commission's Offices (Miller Manor, Baker Commons, S. Industrial) and on the Commission's website, beginning January 26, 2018 thru March 19, 2018. The required Public Hearing was held on March 21, 2018 during the regularly scheduled Board Meeting to further receive resident and community comments and no additional comments were received.

The Plan is now complete and ready for Board consideration and approval and subsequent execution of relevant certifications by the President of the Board and the Executive Director.
