Whereas, Mark Maxey is the owner of property commonly known as 2965 Kimberley Road, Ann Arbor, Michigan 48104, described at Liber 5112, Page 985 of Deeds, Washtenaw County Records; and

Whereas, Marc Maxey has signed a grant of easement for sidewalks, described as:

Commencing at the Southeast Corner of Lot 10 of Kimberly Hills Subdivision being in the Southwest 1/4 of Section 3, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan; thence S00°59'00"W 706.09 feet; thence N50°28'01"W 10.00 feet along the Northerly line of Packard Road (66' wide) to the POINT OF BEGINNING; thence continuing along the Northerly line of Packard Road (66' wide) N50°28'01"W 23.00 feet; thence N39°31'59"E 2.50 feet; thence S50°28'01"E 23.00 feet; thence S39°31'59"W 2.50 feet to the POINT OF BEGINNING. Being a part of the SW 1/4 of Section 3, T3S, R6E, Pittsfield Township, Washtenaw County, Michigan.
