Resolution Recognizing Girls Group as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Girls Group is a 501(c)3 civic nonprofit agency that empowers young women in middle school and high school to achieve emotional and economic self-sufficiency by graduating high school and creating meaningful college and career pathways.

Passage of the attached resolution will allow Girls Group to hold raffle at Ann Arbor Marriot Ypsilanti, located at 1275 S. Huron St., Ypsilanti, Michigan 48197. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
