Whereas, The territory hereinafter described is located in the Township of Ann Arbor and is adjacent to the corporate limits of the City of Ann Arbor;

Whereas, The City of Ann Arbor Parks and Recreation Services is the owner of said property; and

Whereas, It is the desire of The City of Ann Arbor Parks and Recreation Services to annex said territory to the City of Ann Arbor, pursuant to the provisions of Act 359 of the Public Acts of the State of Michigan for the year 1947, as amended;

RESOLVED, That the following described lands and premises situated and being in the Township of Ann Arbor, Washtenaw County, Michigan, be detached from said Township of Ann Arbor and annexed to the City of Ann Arbor, to-wit:

"Beginning at W 1/4 corner of sec. 31, thence N 00°14'37" E 599.10 ft., thence N 89°52'59" E 736.99 ft., thence S 00°19'00" W 600.51 ft., thence S 89°58'31" W 162.68 ft., thence S 89°58'31" W 573.54 ft. to POB."
