Resolution Recognizing Out Loud Chorus as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Out Loud Chorus is a 501(c)3 civic nonprofit agency that is a mixed chorus for the LGBT community, yet open to all. Out Loud provides continuing music education and performance experience open to many levels of ability and committed to embodying the diversity of our community. In addition, the Out Loud Chorus seek to educate the general public about choral music, and, through performances to reduce bigotry and discrimination against our community.

Passage of the attached resolution will allow Out Loud Chorus to hold raffle at Freight House, located at 100 Market Pl., Ypsilanti, Michigan 48198. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.

Whereas, P.A. 382 of 1972, as amended, requires that local civic nonprofit organizations be recognized by resolution adopted by the local governmental subdivision in which the organization conducts its principal activities and that a copy of said resolution be filed with any application for a license to conduct a bingo, raffle or charity game(s);

Whereas, Out Loud Chorus has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and

Whereas, Out Loud Chorus is a local civic nonprofit organization as defined by P.A. 382 of 1972, as

amended, which should be recognized for its ability to empower LGBT members of our community, continuing musical education, a commitment to diversity, and a commitment to the arts;

RESOLVED, That City Council hereby approve recognition of the Out Loud Chorus as a local civic nonprofit organization operating in the Ann Arbor community for the purposes of its charitable gaming license application as required by P.A. 382 of 1972, as amended; and

RESOLVED, That the City Clerk be directed to provide a certified copy of this Resolution to Out Loud Chorus and to take all necessary administrative actions to provide notice of this Resolution to the Charitable Gaming Division, Michigan Department of Treasury.
