Resolution to Approve the Collective Bargaining Agreement between the City of Ann Arbor and Ann Arbor Police Deputy Chiefs, Teamsters Local 214, effective January 1, 2019 - December 31, 2021 Human Resources Services recommends approval of the new Collective Bargaining Agreement between the City of Ann Arbor and the Ann Arbor Police Deputy Chiefs.

Budget/Fiscal Impact: The recommended changes are within the FY2020/FY2021 adopted budget.

Highlights of the negotiated agreement include:

- 1) Three (3) year agreement;
- 2) 2.75% base wage increase effective January 1 of each year of the contract, retroactive to January 1, 2019;
- 3) The City's actuarial contribution to the eligible DC members' Retiree Health Reimbursement Accounts (RHRA) increased from \$2,500 to \$3,500, retroactive to January 1, 2019;

Other major changes of the negotiated agreement include:

- An annual wellness checkup will be offered to each Deputy Chief, to include a mental health component. The City Administrator and Chief can also request a psychological checkup at any time;
- The car allowance has been transitioned into an equipment allowance, and Deputy Chief's will have the optional use of a take home vehicle which eliminates parking of their personal vehicles and mileage reimbursement;

City Administration recommends approval of the attached Resolution to approve the January 1, 2019 - December 31, 2021 Collective Bargaining Agreement negotiated between the City and the Police Deputy Chiefs.
