Resolution to Approve Ongoing Subscription with Zoom Video Communications, Inc. for Meeting and Webinar Services (\$65,000.00) (8 Votes Required)

The attached resolution seeks approval of City Council in the amount of \$65,000.00 on behalf of the Information Technology Services Unit. These funds are needed to maintain Zoom licensing on a monthly basis to support meetings and webinars to conduct City business during social distancing due to the COVID-19 pandemic. Zoom is the communication platform for City Council meetings, Boards and Commissions, and a variety of other community outreach services.

<u>Budget/Fiscal Impact:</u> This purchase is budgeted in FY2022 at a cost of \$48,000. It is being requested that an additional \$17,000 be appropriated from the FY2022 Information Technology Fund fund-balance to cover the additional cost of Zoom licenses that are anticipated to be needed.
