Resolution to Approve a Two (2) Year Purchasing Agreement with Cadillac Asphalt, LLC for Bituminous Patching Materials, ITB-4724 (\$136,500.00 Annually)

Attached for your review and consideration for approval is a resolution authorizing up to \$136,500.00 annually for the purchase of bituminous patching materials from Cadillac Asphalt, LLC.

The bid was advertised on the City's Website and on the Michigan Inter-governmental Trade Network (MITN) website. One (1) bid was received and publicly opened on August 2, 2022. Cadillac Asphalt, LLC was determined to be a responsible bidder for UPM high-performance asphalt cold mix and Durapatch cold applied instant asphalt repair materials.
