Resolution Authorizing Summary Publication of Ordinance 23-02 - An Ordinance to Amend Chapter 55 (Storm Water Management Systems) of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor

The attached resolution is contingent upon Council approval of Ordinance 23-02 at second reading on February 21, 2023. The City Charter allows summary publication of ordinances that are in excess of 500 words in length upon approval by City Council. RESOLVED, That the publication of Ordinance 23-02 shall be made by the following summary:

Ordinance 23-02 amends the storm water management provisions of Ann Arbor City Code, Chapter 55, Subsection 5.22.3 by eliminating currently offered exceptions, requiring all site plans for parcels 1 acre or greater to provide at least first flush volume management, including impervious area solely for public sidewalk improvements and historic structures in stormwater management system design, and changing the requirements and approval procedures for alternatives to storm water management. The ordinance also combines, reformats, and reorganizes Subsections 5.22.2 and 5.22.3 with additional headings and tables for increased ease of use, consistency, and efficiency.

The effective date of Ordinance 23-02 is 10 days after publication.
