Resolution to Approve E. Washington Street Closing for Arbor Brewing Company 15 Year Anniversary Party - August 13, 2010

Attached for your consideration and approval is a request from Arbor Brewing Company to close half the block of E. Washington Street from S. Main Street to the public alley toward S. Fourth Avenue from Noon on Friday, August 13 to 10:00 A.M. on Saturday, August 14, 2010 for Arbor Brewing Company's 15 Year Anniversary Party celebration. The event itself will run from 5:00 P.M. to 11:00 P.M. on Friday, August 13, 2010. The remainder of the time will be used for set up before the event and cleanup following the event.
