An Ordinance to Amend Chapter 55 (Zoning), Rezoning of 1.2 Acres from UNZ (Unzoned District) to R4C (Multiple-Family Dwelling District), 1943 Jackson Road (CPC Recommendation: Approval - 9 Yeas and 0 Nays) (Ordinance No. ORD-10-30)

AN ORDINANCE TO AMEND CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN Arbor, ZONING MAP

The City of Ann Arbor ordains:

<u>Section 1</u>. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

PRT OF NW 1/4 OF SEC 30, T2S, R6E, DESC AS BEG AT NE COR OF LOT 4 ZAHN SUB, TH N 0 DEG 3 MIN 30 SEC W 33.31 FT, TH N 82 DEG 3 MIN 50 SEC E 149.68 FT, TH S 0 DEG 13 MIN 40 SEC E 395.79 FT, TH W 149.44, TH N 0 DEG 3 MIN 30 SEC W 125 FT, TH N 89 DEG 41 MIN W 1 FT, TH N 0 DEG 3 MIN 30 SEC W 75 FT, TH S 89 DEG 41 MIN E 1 FT, TH N 0 DEG 3 MIN 30 SEC W 141.81 FT TO POB

in the City of Ann Arbor, Washtenaw County, Michigan as R4C (Multiple Family Dwelling District).

<u>Section 2</u>. This ordinance shall take effect and be in force on and after ten days from legal publication.
