### Resolution to Accept and Allocate Michigan Supreme Court State Court Administrative Office Michigan Drug Court Grant Program Grant and Approve Grant Contract (\$60,000.00) (8 Votes Required)

This resolution seeks Council approval for a grant contract with the Michigan Supreme Court State Court Administrative Office (SCAO) to fund the 15<sup>th</sup> Judicial District Court Sobriety Court program, and further seeks authorization to accept and allocate grant funds from the State Court Administrative Office/Michigan Drug Court Grant Program for that purpose without regard to Fiscal Year.

At the discretion of the City Controller, the Court will establish a separate grant account with the City Finance Service Area and will take all other necessary steps to assure the effective administration of this grant.

Whereas, The Michigan Supreme Court State Court Administrative Office (SCAO) invited an application from the 15<sup>th</sup> Judicial District Court for Michigan Drug Court Grant Program funds to continue the operations of a specialized Sobriety Court in 2010 and 2011;

Whereas, The 15<sup>th</sup> Judicial District Court applied for and was awarded \$60,000.00 from SCAO pursuant to that invitation; and

Whereas, It is in the best interests of the City of Ann Arbor and in the best interests of justice to enter into a grant contract with SCAO and to accept grant funds awarded by SCAO for this purpose;

RESOLVED, That City Council approve a Michigan Drug Court Grant Program Contract with SCAO;

RESOLVED, That the Mayor and City Clerk are authorized and directed to execute the contract on behalf of the Court and the City following approval as to form by the City Attorney and as to

substance by the City Administrator;

RESOLVED, That the City Administrator be authorized to accept funds tendered by SCAO pursuant to the contract without regard to Fiscal Year;

RESOLVED, That Council authorize the City Administrator to take all necessary administrative actions to implement this resolution; and

RESOLVED, That City Council authorize the Court to establish a separate grant account to receive, hold, disburse and account for funds awarded pursuant to this grant as the Finance and Administrative Services Area Administrator may determine appropriate.
