Resolution to Approve Street Closing for South Utopia - Saturday, March 12, 2011 Attached for your consideration is a resolution to approve the closing of certain City streets for the South Utopia special event on Saturday, March 12, 2011 from 8:00 AM to Midnight.

The event is being sponsored by the South University Area Association and will include a music festival and fun for all ages from Noon to 10:00 PM on Saturday, March 12, 2011. Participating merchants will make donations from their proceeds on the day of the event to benefit Dance Marathon at the University of Michigan. Dance Marathon is one of the largest student-run non-profit organizations in the state whose goal is to raise funds and awareness for children in need of pediatric rehabilitation
