Resolution Recognizing the Ann Arbor Jaycees Foundation as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License

To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to

submit a resolution from its local governing body recognizing it as a community-based organization.

Ann Arbor Jaycees Foundation is a 501(c)3 non-profit organization that supports the Jaycee's mission to provide young people the opportunity to develop personal and leadership skills through local community service and organizational involvement while expanding the Jaycee Movement.

Passage of the attached resolution will allow the Ann Arbor Jaycees Foundation to hold a Millionaire Party at Doc's Sports Retreat, 19265 Victor Parkway, in Livonia, Michigan. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events.
