Resolution to Authorize Summary Publication of Ordinance No. ORD-11-09 to Amend Sections 5:600, 5:601, 5:602, 5:603, 5:604, 5:605, 5:606, 5:607, 5:608 and 5:610, to Repeal Section 5:611, and to Amend Renumbered Section 5:611 of Chapter 62 (Landscaping and Screening) of Title V of the Code of the City of Ann Arbor

The attached resolution authorizes the summary publication of Ordinance No. ORD-11-09, an ordinance to amend Chapter 62 of Title V in the City Code. The amendments update landscaping and screening requirements for site plan projects.

The City Charter contains provisions to allow summary publications of ordinances that are in excess of 500 words in length. The purpose of this resolution is to reduce the City's printing costs resulting from the required publication of the ordinance revisions.

RESOLVED, That Ordinance No. ORD-11-09 be published by the following summary:
