Resolution to Approve E. Washington Street Closing for Oktoberfest - September 20-21, 2013, Requested by Arbor Brewing Company

Attached for your consideration and approval is a request from Arbor Brewing Company to close half the block of E. Washington Street from S. Main Street to the public alley toward S. Fourth Avenue starting at 8:00 a.m. on Friday, September 20, 2013 through 1:00 a.m. on Sunday, September 22, 2013 for Oktoberfest. The event itself is scheduled to run from 5:00 p.m. on Friday, September 20, 2013 through midnight, Saturday, September 21, 2013. The remainder of the time will be used for set up before the event and cleanup following the event. The intersection of S. Main and Washington Street will remain open during the event.

The sponsor agrees to obtain all necessary permits, pay applicable permit fee(s), provide evidence of proper liability insurance as required, to comply with all City regulations governing the use of the streets and reimburse the City for all event expenses. It is understood that special event permits are conditional until all permit requirements are met.

Notification of the street closings will be provided through the City's website and applicant will notify all impacted businesses.

The sponsor will submit an application for approval from the State of Michigan Liquor Control Commission for temporary sales, service and consumption of alcoholic beverages in the defined areas pursuant to the M.L.C.C. regulations.

The event will be coordinated with all relevant City service units for the purposes of traffic control and for the protection of the health and safety of the participants and the general public.
