Resolution to Approve Street Closing for the Ann Arbor Cinco de Mayo Party on Monday, May 5, 2014

Attached for your consideration is a resolution to approve the closing of Liberty Street between Thompson and Division from 5:00 P.M. to 2:00 A.M. on Monday, May 5, 2014 to stage the Ann Arbor Cinco de Mayo event.

The event is sponsored by Tios Restaurant to celebrate Cinco de Mayo. Bands will perform from approximately 1:00 P.M. to 10:00 P.M. The event will require closing of the following street from 5:00 P.M. on Monday, May 5, 2014 to 2:00 A.M. on Monday, May 5, 2014:

Liberty Street between Thompson and Division

Intersections will remain open during the event.

The sponsor agrees to obtain all necessary permits, to provide evidence of proper liability insurance as required, to comply with all City regulations governing the use of the streets and will reimburse the City for all event expenses. The sponsor will submit an application for approval from the State of Michigan Liquor Control Commission for temporary sales, service and consumption of alcoholic beverages in the defined areas pursuant to the M.L.C.C. regulations.

Notification of the street closings will be provided through the City's website. The sponsor will also notify neighboring business with either face-to-face contact or flyers.
