Resolution to Accept a Water Main Easement at 1430 South Maple Road from Grace Bible Church of Ann Arbor, Michigan (8 Votes Required)

This easement is in standard form and is conveyed without cost to the City.

Whereas, Grace Bible Church of Ann Arbor, Michigan, a Michigan nonprofit corporation, is the owner

of property commonly known as 1430 S. Maple Road; and

Whereas, Grace Bible Church of Ann Arbor, Michigan, has signed a grant of easement for water mains and appurtenances, described as:

Commencing at the East 1/4 corner of Section 36, T2S, R5E, City of Ann Arbor, Washtenaw County, Michigan; thence N 01°19'00" W 256.91 feet along the East line of said Section 36 and the centerline of Maple Road (66 feet wide); thence S88°41'00"W 33.00 feet to the West Right of Way of Maple Road (66 feet wide) and to the POINT OF BEGINNING of a 40 foot wide easement for water main described along the centerline as follows; thence S88°41'01"W 40.83 feet; thence N70°10'04"W 54.48 feet; thence N23°21'03"W 155.14 feet; thence N68°37'00"W 81.94 feet; thence S89°26'22"W 86.89 feet to reference point "A"; thence N00°33'38"W 41.68 feet; thence N06°04'21"W 48.67 feet; thence N16°25'39"E 8.00 feet to reference point "B"; thence N16°25'39"E 8.00 feet to the beginning of a non-tangential curve to the right, thence along a curve to the right, 164.42 feet, radius 268.95 feet, central angle 35°01'40", long chord N53°51'04"E 161.87 feet; thence N72°40'39"E 39.35 feet to reference point "C"; thence N17°19'21"W 180.88 feet; thence N18°52'52"W 31.39 feet; thence N22°43'19"W 36.00 feet; thence N17°43'19"W 18.00 feet; thence N12°43'19"W 103.15 feet to reference point "D"; thence N12°43'19"W 123.78 feet to the Point of Ending and also reference point "E".

Together with and commencing from reference point "A" a 40 foot wide easement for water main described along the centerline as follows; thence S89°26'22"W 25.00 feet to the Point of Ending.

Together with and commencing from reference point "B" a 40 foot wide easement for water main described along the centerline as follows; thence N73°34'21"W 22.05 feet; thence N62°19'21"W 42.60 feet; thence N17°19'21"W 148.66 feet; thence N39°49'21"W 129.74 feet; thence N84°49'21"W 41.64 feet to the Point of Ending.

Together with and commencing from reference point "C" a 40 foot wide easement for water main described along the centerline as follows; thence N72°40'39"E 25.00 feet to

the Point of Ending.

Together with and commencing from reference point "D" a 40 foot wide easement for water main described along the centerline as follows; thence S76°17'59"W 33.26 feet to the Point of Ending.

Together with and commencing from reference point "E" a variable width easement for water main; thence S76°33'23"W 237.05 feet; thence N13°26'37"W 31.20 feet; thence N76°41'00"E 245.92 feet; thence N01°19'00"W 9.56 feet; thence N76°33'23"E 12.06 feet; thence N62°26'20"E 135.65 feet; thence along a Non-Tangent curve to the Right, 78.98 feet, radius 225.67 feet, central angle 20°03'10", long chord N73°45'49"E 78.58 feet; thence N82°36'40"E 19.85 feet; thence S89°47'49"E 31.33 feet; thence S01° 19'00"E 40.01 feet to the West Right of way of Maple Road (66 feet wide); thence N89°47'49"W 29.74 feet along the West Right of way of Maple Road (66 feet wide); thence S82°36'40"W 17.63 feet; thence along a Non-Tangent curve to the Left, 64.89 feet, radius 185.67 feet, central angle 20°01'33", long chord S73°53'53"W 64.56 feet; thence S62°26'22"W 140.18 feet; thence S76°33'23"W 27.88 feet to the Point of Beginning or reference point "D". Being part of the Northeast 1/4 of Section 36, T2S, R5E, City of Ann Arbor, Washtenaw County, Michigan.

RESOLVED, That the City of Ann Arbor hereby accept this grant of easement.
