Second Quarter 2008 Investment Portfolio Report

Attached for your information is the City's investment portfolio report for the second quarter 2008. At June 30, the portfolio calendar year-to-date return on investments net of fees was 4.10%. The portfolio return net of fees for the quarter was 3.79%. The weighted average yield for the portfolio for the second quarter was 4.08%, which exceeded the 12-month trailing rate of the 2-year Treasury Note as of June 30 (3.09%) by 99 basis points. The weighted average effective maturity at quarter end was 639 days.

The Governmental Accounting Standards Board requires under Statement 31 that all investments be recorded at fair value versus amortized cost. At quarter end, the amortized cost value of the portfolio was \$182,800,726.72. If investments were recorded using the fair value method, the value of the portfolio would be \$184,911,211.71. Recording investments at fair market value, the portfolio experienced an unrealized gain of \$2,110,484.99.
