ANN ARBOR AREA TRANSPORTATION AUTHORITY

WHEREAS, the Charter Township of Ypsilanti desires to join the Ann Arbor Area
Transportation Authority; and

WHEREAS, the Ann Arbor Area Transportation Authority (AATA) is supportive of the action
and has approved Amendment # 3 of the Articles of Incorporation of the Ann Arbor
Transportation Authority; and

WHEREAS, Amendment # 3 of the Articles of Incorporation of the Ann Arbor
Transportation Authority would add the Charter Township of Ypsilanti as an incorporator
and give the Charter Township of Ypsilanti a seat on the board, and provide for other
things; and
