## CALL TO ORDER

*Chairperson Rubin called the meeting to order at 4:37 p.m. in the Washtenaw County's Board of Commission Public Meeting Room, 220 N. Main Street.*

## PUBLIC COMMENTARY

*John Petts, of DF Land Development of the Domino's Farm Company, addressed the Commission regarding a 58.17 acres parcel submitted through the Washtenaw County Parks and Recreation Natural Area Preservations Program that is being jointly considered by the City of Ann Arbor. The property is currently in litigation with Ann Arbor Township. Washtenaw County Parks has completed a review and appraisal of the property both the National Areas Technical Advisory Committee and the Parks and Recreation Commission issued recommendations to pursue this property contingent upon the participation of additional parties (the Ann Arbor Greenbelt Advisory Commission and Park Advisory Commission). The property is adjacent to the City's Marshall Park and is within a short distance of U of M wooded area and the County's Goodrich Preserve area. All of the properties are south of M-14, between Dixboro Road and the Domino's Farm Complex. The County's appraisal was reasonable enough to be consider discussions and process however, they are coming up against a June 14, 2010 trial date.*

*He said that they were seeking to secure a commitment of interest from the City for this property, in order to petition the Judge to delay the trial, to permit discussions to continue and to hopefully conclude an agreement. They believe that the Greenbelt's action as well as the County's action would convince a judge that a delay in the schedule is merited and that the details of any agreement could be worked out.*

*Commissioner Bloomer said that an exposition of agricultural production on the Earl Horning Farm is scheduled to take place in Washtenaw County on June 26, 2010. The event usually draws 2,000 to 3,000 people and breakfast is served. Tickets are provided through the Co-Operative Extension Service. The event is worthwhile and is a way for urbanites to see how a great deal of our food is produced.*

A motion was made by Commissioner Ezekiel, seconded by Commissioner Allen, that the Commission recommend to City Council to partner with Webster Township on the Purchase of Development Rights on the property identified in Application No. 2010-03 and to recommend a contribution of \$120,870.00 toward the purchase of the property due to the property's proximity to other protected farms, landowner contribution and opportunity for additional partnership with Webster Township. On a voice vote, the Chair declared the motion carried.
