**AMENDMENT NUMBER 1 TO
TETRA TECH, INC.
AND THE CITY OF ANN ARBOR
FOR 2015 GEOTECHNICAL SERVICES**

The City of Ann Arbor, a Michigan municipal corporation, with offices at 301 E. Huron St. Ann Arbor, Michigan 48107-8647 ("City") and Tetra Tech, Inc., a Michigan Registered Corporation with its offices at 710 Avis Dr, Ann Arbor, MI 48108, ("Contractor") agree to amend the professional services agreement for the 2015 Geotechnical Services (RFP #941) executed by the parties dated September 30, 2015, as follows:

- 1) Article V.A. **COMPENSATION OF CONTRACTOR**, is amended to read as follows:

The Contractor shall be paid on the basis of reasonable time spent and materials used at the rates and prices specified in Exhibit B for acceptable work performed and acceptable Deliverables received. The total fee to be paid the Contractor for the Services shall not exceed \$30,550.00. Payment shall be made monthly following receipt of invoices submitted by the Contractor, and approved by the Contract Administrator.

All terms, conditions, and provisions of the original agreement between the parties executed September 30, 2015, unless specifically amended above, are to apply to this amendment and are made a part of this amendment as though expressly rewritten, incorporated, and included herein.

This amendment to the agreement between the parties shall be binding on the heirs, successors and assigns of the parties.
