CALL TO ORDER

Commissioner Ezekiel called the meeting to order at 4:35 p.m. in Council Chambers, 301 E. Huron Street.

Jack Smiley, volunteer with the Southeast Land Conservancy, serving on the Land Protection Committee, said that they are very excited about the possibility of partnering with the Greenbelt Program and the Washtenaw Natural Area Program and protecting additional land in the area known as the Superior Greenway. Washtenaw County, the Greenbelt Program, Superior Township and the Conservancy have already protected over 1800 acres of land over the years in the Superior Greenway, which is between Ann Arbor and Detroit. Mr. Smiley said that they hoped to protect even more land within that same area.

NEW BUSINESS

1 <u>11-1437</u> Staff Update - Bus Tour

Ginny Trocchio of The Conservation Fund updated dated the commission regarding the application of Shannon Brines to become a member of the Commission. His application for appointment to the Commission will be considered at the next regular session of City Council. Mr. Brines should be confirmed in time for the December Greenbelt meeting.

Ms. Trocchio updated council on the Greenbelt Bus tour that took place after the last commission meeting. The tour was very well attended with a little over 30 people attending. Feedback from the public was great. A lot of them did not know much about the Greenbelt or farming so she felt that the right group of people were targeted. A letter was received from Stephanie Buttrey thanking them for organizing an informative tour.

Ms. Trocchio said that she has also heard that people are signing up for another tour next year, even though a date has not been set. So the word is getting out to Ann Arbor residents. They really enjoyed meeting some of the land owners they have worked with. They have talked about other ways to have that same kind of interaction just without doing a tour. One suggestion was having a discussion at the library with some of the land owners they have worked with.

Commissioner Garfield suggested adding a discussion topic to an agenda to discuss and come up with more ways to notify the public of what the greenbelt is doing and is all about.

2 Appraisal Policy

Ms. Trocchio said that they have heard from the farm and ranch grants and the deadline has been set for February. This is the time of year where they would want to get properties, appraisals and applications lined up to meet the deadline. In particular, with the pending potential boundary expansion that will be going to Council in December, if those are approved there could be more land owners that may be interested and they could possibly get more applications. The time frame to get those applications and appraisals started is going to be tight.

Ms. Trocchio said she talked with the executive committee about getting approval to direct staff so that they could move forward on some of those appraisals if the applications come in that would be qualified for farm and ranch grants and that meet their strategic objectives. They would then come to the commission for formal approval.

Commissioner Ezekiel clarified that The Conservation Fund would like to get permission to move forward with an appraisal without the Commission specifically asking the Conservation Fund to do a particular appraisal because of the tight time schedule to get properties ready for FFRP applications.

A motion was made by Commissioner Rother, seconded by Commissioner Bloomer, that the Commission authorize Ms. Trocchio to move ahead with the appraisals as needed by December 31, 2011. On a roll call, the vote was as follows with the Chair declaring the motion carried:
